



# CONDA PRIVACY POLICY on Investment and Payment Service

## 1. INTRODUCTION

- 1.1. CONDA (hereinafter "we" or "us") considers the protection of your personal Data in the context of all the services provided by us to be very important. Therefore, the collection, processing and use of your personal Data is done solely in accordance with the relevant statutory provisions.
- 1.2. This privacy policy explains the how CONDA AG, City Donau-City-Straße 6, 1220 Vienna, Austria, represented by general managers Paul Pöltner and Daniel Horak (hereinafter as CONDA) processes and maintains personal data about users and investors of CONDA platform ("data").
- 1.3. CONDA is subject to the privacy laws of Republic of Austria (DSG 2000) and General Data Protection Regulation (GDPR). This Privacy Policy Statement outlines how we manage and protect the personal Data we are given and hold about our users (The "Policy").
- 1.4. The use of the CONDA platform constitutes your acceptance of the Policy and any other legal notices and statements contained on this platform. Your use of the CONDA platform is governed by the version of the Policy in effect on the date each CONDA website is accessed by You. - 1.5. We process and use User Data when you (a) use (browse) site of CONDA platform; (b) subscribe to our newsletter; (c) make a pledge of investment through the CONDA Investment process - conclude a valid Investment Agreement with the Project Company.

## 2. USE OF DATA

### 2.1. Use (browsing) of site of CONDA platform

- 2.1.1. When you enter our site of CONDA platform upon consenting the use of cookies (as detailed in our cookie policy available on [www.conda.at/cookies](http://www.conda.at/cookies)).
- 2.1.2. Recipients of this category of personal data (use of site of CONDA platform) are IT providers (Kinsta Ltd.; Amazon Web Services, Inc.; Auth0®, Inc.; Research Industrial Systems Engineering GmbH; Microsoft Corporation (Azure Services); Functional Software, Inc.) which have provided CONDA with guarantees as demanded by GDPR. USA based IT providers are all Privacy Shield certified.

### 2.2. Subscription to newsletter

- 2.2.1. When you subscribe to our newsletter (giving us consent) we use provided email address in order to keep you posted on news regarding our events, general development of CONDA, upcoming crowdfunding campaign and progress reports on financed Project Companies.
- 2.2.2. Recipient of this category (newsletter) of personal data is Mailchimp newsletter provider The Rocket Science Group, LLC and SendGrid Newsletter provider SendGrid, Inc. Both providers are USA based and Privacy Shield certified.

### 2.3. Investing

- 2.3.1. In order to comply with legal and regulatory requirements and obligations we collect the following data from you as part of our KYC (Know Your Customer) and AML-CFT (Anti Money Laundering and Combating the Financing of Terrorism) procedures.

2.3.2. We use your email address once you've become an investor to Project Company to notify you on progress of Project Company and also to keep you posted on news regarding our events, general development of CONDA, upcoming crowdinvesting campaign and progress reports on other Project Companies by sending you newsletters. We consider this as our legitimate interest therefore we do not seek a consent from you.

2.3.3. Personal data collected and processed is into following tiers (tier calculation – all investments per investor are summed up):

- a) Registered Profile (TIER 0)
- b) Investment from 0 € to 5000 € (TIER 1)
- c) Investment from 5000 € to 15000 € (TIER 2)
- d) Investments above 15000 € (TIER 3)

2.3.5. Receptient of this category (investing) of personal data are IT providers (Amazon Web Services, Inc.; Research Industrial Systems Engineering GmbH; Microsoft Corporation (Azure Services) which have provided CONDA with guarantees as demanded by GDPR. USA based IT providers are all Privacy Shield certified.

## 2.4. Payment Service

2.4.1. In order for a transaction to be executed we employ Lemon Way SA as our payment service provider with whom you conclude a Framework Agreement during the Investment Process.

2.4.2. Following data is sent to Lemon Way SA collected through our KYC and AML-CFT process as detailed in point 2.3. of this Policy. Personal data provided to Lemon Way is divided into following tiers (tier calculation – all investments per investor are summed up):

- a) Investment from 0 € to 15000 € (TIER 1)
- b) Investments above 15000 € (TIER 2)

2.5. After an investment is made, we display your first name, location, and the sum you invested on the Crowdfunding Campaign of Project Company.

2.6. Receptient of this category of personal data (payment service) is Lemon Way SA.

### 2.7. Transfer to Project Company

2.7.1. In order for you to validly conclude an investment agreement we transfer the following data to Project Company you have pledged to invest in – this particularly pertains to, though not exclusively, to your first and last name, your sex, your address, your investment amount, your bank details for exemption orders, and your tax identification number. Said personal data is also used in order for Project Company to process and execute pay-outs based on Investment Agreement.

2.7.2. Recipients of this category of personal data (Project Company) are EU based companies with whom CONDA has concluded a business contract and have provided CONDA guarantees as demanded by GDPR.

## 3. SHARING INFORMATION

3.1. We do not disclose or share information about any of our users (whether active or inactive) to third parties other than in the manner and entities set in this Policy.

3.2. To respond to a subpoena or court order, judicial process or to regulatory authorities, either having jurisdiction over us or over our users and to protect against fraud, unauthorized transactions (such as money laundering), claims or other liabilities.

## 4. DATA SUBJECT RIGHT AND RETENTION PERIOD

4.1. In respect to personal data collected for a purpose of newsletter (2.2.) and when browsing our site of CONDA platform (2.1.) you are entitled to be informed, to have access, to rectification, to restriction of processing, to data portability, erasure and objection.

4.1.1. We store this data until you withdraw your consent

4.2. In respect to personal data collected for purpose of investing (2.3.) and Payment Service (2.4.) you are entitled to be informed, to have access, to rectification and to data portability.

4.2.1. We store this data for the duration of Investment agreement and beyond for the legally required period.

## 5. SECURITY AND INTEGRITY OF DATA

5.1. We protect your data by using data security technology and using tools such as firewalls and data encryption. All data collected is always transferred done via encrypted TLS protocols (transport layer security, also known as SSL). We also require that you use a personal username and password every time you access your account online. We restrict



access to data at our offices so that only officers and/or employees who need to know the data have access to it.

- 6.1. This Policy will be reviewed from time to time to take account of changes to our operations or practices and, further, to make sure it remains appropriate to any changes in law, technology and the business environment. Any information held will be governed by our most current Policy.
